As a certified life coach, it is incredibly satisfying to see Shelton join the many communities across our Country to ensure the inclusivity of all. As a small town, we are all made better by wholeheartedly accepting every person as an important, valuable member of our community. In truth, we are all far more alike than not and coming together to support one another significantly improves the quality of life here in Shelton. Furthermore, as the leaders of Shelton, being a symbol of tolerance models correct and appropriate behavior.

For years, we have been dealing with continual damage to our cars and our property from other people's cats. Over the years we have spent a considerable amount of money on various cat deterrents such as ultrasonic pest deterrent, motion sensor sprinklers, and citrus based scents to try and stop this damage, but it never ends.

The hoods of our cars suffer continuous scratches and damage from multiple cats constantly jumping on them. The last couple of weeks we have been refreshing our landscaping and putting new beauty bark down and it's being turned into a giant litter box not to mention the damage to the plants. We have spent a lot of time and money trying to protect our garden boxes and have had to put fencing around them to try and keep the cats out. The cats have ruined our lawn furniture by climbing on it and have turned our bird feeders into an all you can eat buffet. We have \$10,000 dollars' worth of fencing that does nothing to stop this. The cats have done considerable damage to some of our fencing by sharpening their claws on it.

We are tired of all the money and time spent on this problem. We don't feel that we should have to spend the few hours a week we get away from work having to deal with other people's cats and their destruction. The owners of the cats are not being held accountable for their animal's behavior. Even the pet adoption place's make you sign a contract saying that you will keep your cat inside for its own safety. If dogs were to be causing this amount of damage to our property there are repercussions for the owners because the dog is supposed to be licensed and on their owners property, but for some reason cats are allowed to be very destructive with no ordnances in place.

As cat owners whose animals never bothered anyone because they lived inside, we do not understand why all animals in the city limits are not required to be licensed and stay on their owner's property. How much more of our time and money are we expected to have to spend on this?
